The YELLOW bordered area shows the name of the logged in user.

The ORANGE bordered area shows if and how many new open tasks are to be completed with the possibility to directly switch there by clicking on them.

The BLUE bordered area shows the chat function. By activating the button you can directly chat with one of our support team. The chat button will appear at the bottom right.

The VIOLET bordered area displays the navigation menu.

The RED bordered area shows a button to quickly show or hide the navigation menu.

Navigation menu

The width of the navigation menu can be individually adjusted by clicking and dragging the small white arrows on the right side of the navigation menu.

3 Import master data

General information

If a large number of employees has to be created, it would be relatively time-consuming to do this via the menu item **Persons** (page 79). Therefore there is the possibility to enter the **employe master data** and all other relevant information concerning the persons. This could be created comfortably in a Microsoft Excel file, from where the data is finally read out and imported. The document provided for this purpose is described below.

The columns highlighted in red on the screenshots are mandatory fields - the yellow fields can be filled **optionally**.

3.1 The document

3.1.1 Employee master data

This page deals with the personal data of the employees and the assignment to **loose groups**.

An explanation of those columns that require such an explanation:

Employee ID

This refers to the personnel number assigned to the employee in the company.

User-ID

This is the user name under which the employee is to be created in Personalwolke. The user name can be any combination (in this case, the first 3 letters of the first and last names would be used).

- **OU short for: organizational unit** This includes the various departments of the company, such as management (GF), personnel (PERS) etc. This column contains the short names of the relevant OU.
- User / Management / Admin



In the Personalwolke these are the names of the 3 different *loose groups*. Depending on which of these groups the user is assigned to (Y = Yes, add / N = No, do not add), he or she receives different authorizations in the Personalwolke.

3.1.2 Organizational units

This page is used to define the hierarchical groups / departments and their relationships to each other.

• Shortname

This consists of the fixed mandat short code (XY) and a freely selectable short code of the OU / department.

• Name

The full name of the OU / department.

• Parent

The short name entered here indicates which OU the department is subordinate to in the question. This allows a creation of a clear hierarchical order. In the screenshot above, root is given for the *management* - this means that the management does not have a superior department = is therefore at the top of the hierarchy.

• Supervisor

Or even **department heads** - here the personnel number must be entered. It is important to make sure that this number is the same as the one entered under personal master data.

Personnel

Like the supervisor, the correct personnel number of the person who has this role for the relevant department must be entered here.

A definition of the roles **superior** and **personnel** is contained in the menu option Roles (page 95).

3.1.3 Daily program

Various working time models can be recorded here, depending on the structure of the company.

• Number



The **daily programs** must be clearly numbered - these numbers can also be used to enter them on the **weekly programs** page.

• Short text

A freely selectable short name for the daily program. In the above case, **G/7.42** stands for a flexitime model (Gleitzeitmodell) with a daily target of **7 hours** and **42 minutes**.

• Designation

As shown in the screenshot, the long name of the program could be chosen to contain the most important information.

• Validity TP Start / End

This is the period in which the daily schedule is valid. Shift models are an exception to the normal case (00:00 - 24:00), since night shifts can extend from late evening to long after midnight.

• Daily target

The daily target working time mentioned above specifies the number of working hours that an employee must work each day (on average) in order to achieve his or her weekly target.

3.1.4 Weekly program

The weekly program determines which daily program is used on which day of the week.

• Short text

A freely selectable short name for the week program. In the above case, **G/38.3** stands for a flexitime model (Gleitzeitmodell), with a weekly working time of **38.3 hours** and a framework time between 07:00 and 18:00 hours.

Long text

As shown in the screenshot, the long name of the program could be chosen to contain the most important information.

• Mon -Sun

The number of the applicable **day program** is entered under the respective short names of the weekdays (Mon - Sun).

4.5 Create new employee

Preconditions

Before you create a new employee, you should answer the following questions:

- In which department is the employee located?
 - Does this department already exist?
 - Yes: Continue with the next question.
 - No: Continue here: Create new department (group) (page 91)
- Which user name does the employee get?
- Which employee ID does the employee get?
- Does the employee have a **special function (role)** in the company (personnel, superior)?
 - No: Continue with the next question.
 - Yes: Which one? Personnel or supervisor or both?
- Should the employee get additional menu items in Personalwolke?
 - Employee / department administration -> Admin
 - Additional evaluation options for employees --> Management
- Which time model (weekly program) should be assigned to the employee?

Once you have answered these questions, you have the minimum information required to create a person. You can also store other personal data about the employee (date of birth, address, e-mail, telephone, etc.).

Create the new employee

Step 1: In the menu tree under Administration, click on Persons.

Step 2: Click New Person above the list of people

Step 3: First name, last name, client, group, user name and employee ID must be filled in. The checkbox **Active user** must also be checked if the employee is to be able to log in to the webdesk. All other fields are optional!

Note: The field for selecting the group is only available after the client has been selected. The fields user name and personnel number are also preset with unchangeable, client-specific prefixes!

Step 5: To enable the user to log in, click on the **Reset password** button under **Password management**. This resets the employee's password to his or her user name (attention, upper/ lower case relevant!) and must be changed during the first login.

Step 6: Add the employee to lose group XX-ALLE.

In order to define the menu items that the employee can select after login, the employee must be added to different lot groups.

It is **absolutely necessary** to add the employee to group **XX-ALLE**. This activates the basic menu items - without this setting no navigation is possible in the webdesk!

To do this, proceed as follows: under the **tab Organisation / Groups**, select the entry **lose groups** from the drop-down menu and add the employee to group **XX-ALLE** under **New Group**.

Step 7: Save

Steps 6 and 7 can now be repeated to add the employee to the **XX-Admin** or **XX-Management** groups, if this admin or management can exercise skills in the webdesk.

The group **XX-Admin** is normally assigned to those employees who should be able to add / edit new persons in the webdesk or create / edit groups (departments) in the organization chart. The membership in the group **XX-Management** activates additional menu items for evaluations / statistics (usually assigned to personnelists / superiors).

Step 8: Special properties for the employee (personnel, superior)

Special functions can be assigned to the employee under the Roles tab. Specifically, the roles Personnel and Superiors, which give the employee extended access rights (for example, a superior can view the monthly journal of his or her subordinate employees) and enable additional menu items. The two roles are also used in the various workflows (leave requests, time corrections, etc.) to control who has to approve these requests.

- To assign a role to an employee, proceed as follows:
- Select the Roles tab
- Click on New Role Owner
- Under New Role Owner, click on the button with the 3 points to select the role Personnel or Supervisor.
- Under competence target
 - Person: this specifies that the current employee performs the selected role (personnel, superior) for the selected employee.
 - Group: this specifies that the current employee performs the selected role (personnel, superior) for the selected group (i.e. for all members of this group).
 - Client: this specifies that the current employee performs the selected role (personnel, superior) for the entire client (i.e. for all employees of the client; useful if, for example, there is to be 1 HR manager for all employees).
- Valid from / to a period can be defined in which this role assignment is valid (can be left empty; then the assignment is valid from now until 1.1.3000 (standard setting)).



The settings made must be accepted with a click on **Save**. This step can be repeated as often as required in order to assign several roles to the employee for different competence goals.

4.6 Calculation of aliquot remaining vacation

General

When a new employee joins the company, it must be decided whether it should be possible to evaluate the aliquot remaining vacation balance during the year. Similarly, it may be necessary to display the aliquot remaining vacation when an employee leaves during the year. For these two cases, a logic has been implemented in the system, which must be parameterized as shown in the following examples.

Info: If no evaluation of the aliquot remaining vacation balance is required, the following steps **do not** have to be carried out.

The data input of the calculated values has to be done via the correction client (to be found under Administration / Time management). A detailed description of how to enter these values can be found at the end of this document.

Examples

Start date time recording (creation of the user in Personalwolke): 01.07.2015

Effective date of leave (date on which annual leave is credited): 01.12.

Explanation of table content:



• Zeile 1

The remaining vacation (= vacation that the employee has not consumed) from 2014 (previous year) is 5 days. This 5 days will be carried into the next year.

• Zeile 2 - Zeile 4

On effective date of leave (01.12.2014), the new annual vacation / remaining vacation (25 days) is added to the remaining vacation from the previous year (5 days). This results in the total remaining leave of 30 days.

• Zeile 5 - Zeile 8

On 01.07.2015, 6 vacation days have already been consumed by the employee. Now the case is, when vacation days are used, they are first deducted from the remaining vacation from the previous year before the current remaining vacation is reduced. As shown in Zeile 1, there are 5 vacation days left from the previous year.

• Zeile 9 - Zeile 11

The current remaining vacation (25 days) is now reduced by the result remaining vacation from the previous year. Since the result remaining leave previous year is negative (in this case (-1)), the new balance on 01.07.2015 is 24 days.

• Zeile 12

The number of days from 01.12.2014 to 01.07.2015 is 213.

Explanation of table content:

• Zeile 1

The remaining vacation (= vacation that the employee has not consumed) from 2014 (previous year) is 5 days. This 5 days will be carried into the next year.

• Zeile 2 - Zeile 4

On effective date of leave (01.12.2014), the new annual vacation / remaining vacation (25 days) is added to the remaining vacation from the previous year (5 days). This results in the total remaining leave of 30 days.

• Zeile 5 - Zeile 8

On 01.07.2015, 4 vacation days have already been consumed by the employee. Now the case is, when vacation days are used, they are first deducted from the remaining vacation from the previous year before the current remaining vacation is reduced. As shown in Zeile 1, there are 5 vacation days left from the previous year.

• Zeile 9 - Zeile 11



The current remaining vacation (25 days) is now increased by the result of the remaining vacation from the previous year. Since the result of the remaining leave from the previous year is positive (in this case (+1)), the new balance on 01.07.2015 is 26 days.

• Zeile 12

The number of days from 01.12.2014 to 01.07.2015 is 213.

Explanation of table content:

• Zeile 1

The remaining vacation (= vacation that the employee has not consumed) from 2014 (previous year) is 5 days. This 5 days will be carried into the next year.

• Zeile 2 - Zeile 4

On effective date of leave (01.12.2014), the new annual vacation / remaining vacation (25 days) is added to the remaining vacation from the previous year (5 days). This results in the total remaining leave of 30 days.

• Zeile 5 - Zeile 8

On 01.07.2015, 22 vacation days have already been consumed by the employee. Now the case is, when vacation days are used, they are first deducted from the remaining vacation from the previous year before the current remaining vacation is reduced. As shown in Zeile 1, there are 5 vacation days left from the previous year. After deduction of the 22 consumed vacation days, the remaining vacation is completely used up from the previous year.

• Zeile 9 - Zeile 11

The current remaining vacation (25 days) is now reduced by the result remaining vacation previous year. Since the result of remaining vacation previous year is negative (in this case (-17)), the new balance on 01.07.2015 is 8 days.

• Zeile 12

The number of days from 01.12.2014 to 01.07.2015 is 213.

Input in the correction client

To enter the values calculated according to the above examples in the system, the following accounts must be corrected via the correction client.

With an absolute correction (=24), the number of open vacation days in the current year is entered.

• Remaining vacation (previous year)

With an absolute correction (=0), the number of remaining vacation days from the previous year is entered here, which remain after deduction of the consumed vacation. If the result is negative, as in examples 1 and 3, no correction needs to be made here!

• Remaining vacation (pre-previous year)

With an absolute correction (=0), the number of remaining vacation days from the preprevious year is entered here, which remain after deduction of the consumed vacation. If the result is negative, no correction needs to be made here!

With an absolute correction (=0), the number of vacations day is entered, that the employee has already consumed since the last effective date of vacation.



The calculated aliquot remaining vacation is displayed from the following correction day (02.07.) in the line "Resturlaub ges. aliquot" (marked in green).

4.7 Entry of employees

4.7.1 Creation of persons in the future & past

New employees aren't created in the system exactly on the day they join. For this reason, Personalwolke Time supports different scenarios for a new person

- subsequently or
- in the future

in the system.

In our system, person master data records have a "Valid from" and a "Valid to" date. When a new person is created, this data is filled automatically and cannot be changed manually.

To enable time recording into the past for subsequently created persons, the field "**Start of time recording**" must be set to a date in the past.

4.7.1.1 Relevante parameters

The following parameters must be entered under "**Modules**" -> "**Time recording**" in the person master record.

A description of the remaining fields can be found under "Field Description Master Record"

4.7.1.1.1 Start of time recording

If you check the checkbox "Activate time recording" in the Modules / Time recording tab, you must enter the start date of time recording correctly. The start date of the time recording must be set to the day before the day from which times are to be recorded in the system.

This date cannot be in the future. It cannot also be the current date. It must be a date in the past, such as yesterday. If the current date is entered, it is automatically replaced with yesterday's date when saving.

This is useful so that you can already enter the remaining leave and other values for the previous day, so that you have already settled values in the system from the entry date.

Example:

• Entry date: per 01.01.



- Person is created on 08.01. in Personalwokle
- The start date of Time Management must be set to 31.12. so that the time recording can start with 01.01.

4.7.1.1.2 Entry date

When you create a person, you **must** specify the entry date. This enables that this person can be displayed in various evaluations.

4.7.1.1.3 Fictitious entry date

The fictitious entry date is important if an employee has an earlier, fictitious entry date due to previous employment periods being taken into account. The system therefore separates a) the actual entry date and b) the fictitious entry date, which is then also used to calculate the leave entitlement.

Example:

- Entry date: per 01.07.
- creditable prior periods of employment: 6 months
- Fictitious entry date: 01.01.

4.7.1.2 Examples of the personal system

4.7.1.2.1 Example 1: The employee is already in the company and is created later in time recording:

- 1. Time recording is activated by the entry date into the past. The postings must then be entered subsequently.
- 2. Time recording is activated with the current time. Afterwards, the balance values and vacation data (described below) must be manually added via the correction client (to be found under Administration / Time management / Correction client).

4.7.1.2.2 Example 2: Employees join the company for the first time:

1. The employee can be created in advance in Personalwolke and only activated for time recording on the entry date.

Example: Entry date: 01.04.

The employee is created on 25.03. so that the information already exists an Personalwolke can be used.

Time recording must then be activated on 01.04. with the date of 31.03.

2. The employee can be created on the entry day and time recording can be activated on the previous day.

Example: Entry date: 01.04.

The employee is created in the system on 01.04. and the start date of Time Management is set to 31.03. This enables the employee to record his or her working times and absences as of 01.04.

4.7.1.3 Vacation entitlement

For new employees, you must specify the leave entitlement and the "key date of addition" so that the new leave entitlement is added to the addition date. If the new annual leave is credited per calendar year, you must enter 01.01. as the key date for the addition. If the entry date is relevant, the entry date must be entered here.

If an employee is created in the personnel cloud who is already in the company, the days since the last addition and possibly the entitlement from the previous year or previous year must also be entered. These are entered in the correction client under Administration / Time management / Correction client. There the view must be switched to the daily view and the correct values must be entered on the first day in the time recording.

Example:

If Max Mustermann has entered on 01.01.2019 and is then created on 01.04.2020 in time recording, the vacation values must be stored as follows:

- Holiday entitlement: 25
- Date Added: 01.01.2019
- Days since last added: 31 (January) + 29 (February 2020 leap year)+ 30 (March) + 1 (current day) = 91 days
- Holidays used up in 2019: 8 days
- Spent vacation in 2020: 7 days
- Remaining leave previous year: 10 days
- Remaining vacation total: 35 days (10 remaining days from 2019 + 25 days from 01.01.2020, vacation days are always deducted from the oldest remaining vacation first until they are used up)

4.7.1.4 Aliquoting of the year of entry

The parameter "Factoring the entry year" controls whether the leave entitlement is to be added on a pro rata basis in the first six months and must be set to "legally compliant".

If the employee is subsequently created in time recording and the entry date is not in the current year, then set this parameter to "No".

Example:

- Mr. Mustermann joined on 06.03.2019.
- Mr. Mustermann's company has been created in the personnel cloud since 01.01.2020.
- Time recording is therefore activated for Mr. Mustermann as of 31.12.2019.
- If the factoring of the entry year is activated, the leave entitlement is added to him in 2020 on a factoring basis.
- As a result, he or she would not receive the 25 leave days specified on 06.03.2020.
- In this case, the parameter "Factoring the entry year" must be set to "No".



4.8 Session Expired

In some cases, users get the error message that the session is expired. In many cases this appears due to a faulty cookie in the browser. To fix this error you can either clear the cookies and cache or open the browser in an incognito window / private window.

An employee's overtime can be credited to the balance, through the "Correction Client".

You can find the "Correction Client "in your menu tree under "Administration" -> "Time Management" -> "Correction Client".

Since individual parameters can be set for daily views and those varies for each customer depending on their internal guidelines. We highly recommend that you make these changes with your consultant. Our Support Team will be happy to assist you further.

To begin with the evaluation of overtime the following parameters should be set in the "Employee's master account" under the "Modules"-Tab.

• Working hours outside of the time framework

This option determines whether the employee is entitled to accumulate additional work hours outside of the time framework set by the employer. If overtime is not permitted outside the time framework, but is still performed, the overtime is shown as unevaluated time, which must be submitted for approval to management separately.

Option	Beschreibung
Yes	Eligibility for overtime outside the time framework
No	No entitlement to overtime outside of the time framework

Example:

If the employee "Rudi Renner" is entitled to overtime outside of the time framework, and he works 2 additional hours, it will normally be credited to his daily balance. However, if he is not entitled to overtime outside of the time framework, these 2 hours will be cut off and not shown. "Rudi Renner" has then the option to submit an application for time worked outside the time framework. If this application is approved by the supervisor, the previously unevaluated hours will be credited to his balance according to the specified overtime factor.

• Overtime entitlement beginning

The date from which the authorization for overtime applies to the employee concerned is entered here. This means that overtime worked remains in the overtime accounts and can therefore be paid out with the specified overtime factor.

This option requires the authorization for "work outside of time framework "!

• Overtime entitlement end

The date up to which the authorization for overtime is valid for the employee is entered here.



This only works if the employee is allowed to work overtime!

• Overtime invoiced at the beginning of the balance

This setting is relevant, if the company decides not to credit overtime to a special account, but instead to credit it directly to the time balance multiplied by a certain factor (e.g., x 1.5). The date from which a factored credit for overtime is to be made on the time account is set here.

This only works if the employee is allowed to work overtime!

• Overtime billing at the End of the balance

The end date is set here, up to which a factored credit for overtime is to be made on the time account.

This only works if the employee is allowed to work overtime!

Management employees have the possibilities of the standard employee and additionally

- the menu item Management
- the menu item Reports for various evaluations concerning the company / the employees

Admin employees have the possibilities of the standard employee and additionally

• the menu item **Administration** to perform administrative tasks concerning the company / the employees.

Of course, one or more employees can also be assigned the management and administration ability at the same time.

Workflows are controlled by freely assigning the **roles** of supervisors and personnel to individual employees and/or groups.

5.1 Booking

General informations

The **booking mask** offers the user the possibility to create time bookings (Present (Absent) / Business Trip / Doctor visit / Official trip).

The date and time are taken from the web server, and the correct booking rhythm (Arrived / Left) is determined by the system. In addition, absence reasons can also be booked (business trip, doctor visit, official trip).

Furthermore, a message can be entered that is visible to colleagues in the **attendance list**.

Examples: Business trip - visit to a customer; present - in meeting / conference, etc.

The "Show Journal" button can be used to provide an overview of the entire monthly journal.

To hide the journal again, click on the "**Hide Journal**" button. This appears automatically when you click on the "**Show Journal**" button.

A successful booking is acknowledged by the server with a message, if errors occur a corresponding error messages appear.

5.2 Booking logic

This page explains how the booking logic works when time is booked in Personalwolke. The respective booking rhythm as well as **different absence reasons** (productive and unproductive) are also taken into account.

Basically, a distinction is made between:

• Normal attendance/absence

This includes the normal booking in at the start of work at the workplace as well as the booking out at the beginning of the lunch break or after the end of work.

• Absence with a productive reason

This includes booking in when physically absent but at the same time productively working for the company. These can be reasons such as active travel time, teleworking or working from home. Absence times with a productive absence reason are taken into account when calculating the working time balance.

• Absence with a non-productive reason

This basically refers to absence during regular working hours due to a special (nonproductive) reason. This can be, for example, illness or a doctor's appointment during working hours.

The most important indicators in the booking window are the **booking status** and the **booking rhythm**, in addition to the date, time and booking reason:

Booking status	The booking status indicates whether the employee is currently present or absent from the office. In addition, for absences with a specific reason (e.g. business trip, doctor's appointment, time off), this reason is also displayed directly in the booking status.
Booking rhythm	The booking rhythm indicates which type of booking ("coming" or "going") will be booked the next time the "Book" button is pressed (without a particular absence reason).

Classic Booking (normal attendance and absence)

This type of booking is probably the most common case of time booking in Personalwolke. This case occurs when the employee is doing his/her normal work with attendance in the office and logs in and out when coming, before and after the break and at the end of the working day. In the classic booking, the "Reason" field in the "New booking" tab remains empty, only the "Do booking" button is pressed.

Before the employee books in at the start of work in the morning, the booking status is initially set to "Absent", the booking rhythm shows "**Coming**" for the next booking. When the employee starts work and logs in, the booking status changes to "Present" and the booking frequency shows "**Going**" for the next booking.

In the course of the day, the employee books out for lunch, books in again after the break and finally books out again at the end of the working day. In this classic booking activity, only those time intervals were recorded in which the employee worked - the **journal therefore shows the working time between the start of work and the lunch break and between the lunch break and the end of work**. These intervals are also fully included in the working time balance as productive working time.

Absence with a productive absence reason

In addition to the normal attendance/absence booking, there are also certain situations in which the employee is **not present at his/her workplace**, but **still performs work for the company**. In these situations, the employee should be marked as absent, but the working time should still be taken **into account in the journal and in the balance**. For this purpose, **productive absence reasons** can be booked in Personalwolke.

If a **productive absence reason** is entered in the booking (e.g. the employee works from home), it is irrelevant whether the previous booking status is "Present" or "Absent" - the employee is **always marked as "Absent**", but supplemented by the productive absence reason (booking status in orange/blue). In contrast to the usual absence (e.g. break, end of work), a **time interval is recorded** in the journal which, in the case of a productive absence reason, is also taken into account **as working time in the balance**.



If the **productive absence has ended** (e.g. end of business trip, end of mobile working), there are **two possibilities**:

Termination followed by absence This occurs, for example, when the employee finishes teleworking and goes home for the day. In this case, he or she must select the same reason for absence again and then press the "Do booking" button. The booking status then changes to "Absent" and the time interval is ended.

• Termination followed by attendance

This occurs, for example, when the employee returns to the office after a business trip and continues his or her work there. If the "Do booking" button is pressed from the absence with a productive absence reason **without specifying a reason**, the **booking status changes to "Present"** and a new time interval is started while the time recording of the business trip/ telework/etc. is ended.

Absence with a non-productive absence reason

There are also certain absence reasons that do not count as working time but must nevertheless be recorded in the system. These include, for example, illness or a visit to the doctor or a visit to the authorities during working hours.

In principle, the booking logic for non-productive absences is identical to the procedure for productive absences. The **booking intervals** are stored in the journal in the same way, but the time recorded for **non-productive absence reasons is not taken into account as working time in the balance**. A time interval with a non-productive absence reason can also be ended either with subsequent absence or with subsequent attendance, as described above.



5.3 Info

5.3.1 Personal / Accounts

General

The user can use this menu option to query the **master data** and **account balances** of the most important time recording accounts for a specific key date.

In the **date field**, the user can enter an alternative date (alternative key date). The date can either be entered directly in the format dd.mm.yyyy (e.g.: 03.04.2021) or selected by clicking on the calendar symbol. By updating (click on the "**Refresh**" button) you will get the account values for the selected key date.

Personal data

In addition to general personal data such as **surname** and **first name**, further information is also displayed:

Employee ID - Personnel number including the fixed prefix (0001 in this case; generally: the first 4 digits of the employee ID)

Username - Login name of the employee whereby the e-mail address can also be used for the login.

Group- the department to which the employee is assigned.

Holidy entitlement - employee's vacation entitlement in days



Account values

The account values provide an overview / summary of the most important time accounts for the **key date** selected under Date:

Time balance- the sum of the actual time (actual attendance) reduced by the target time. Remaining holidays - the currently available remaining vacation in days Unplanned holidays - corresponds to the remaining vacation minus the planned vacation in days. Planned holidays- Planned vacation in days Consumed holidays - days of holiday already consumed Sick days (yearly) - the annual sick days Doctor's appointments (hrl.) - the booked doctor's courses in hours Passive travel time (mly.)

Important: The displayed values are the values for the selected key date!

5.3.2 Journal

General

The **journal** includes all important personal time information for a month, showing the current month up to the present day. One line includes the entries and certain account values per day. The journal is kept in normal minutes, i.e. a break deduction of 0.30 corresponds to 30 minutes.

With the help of the arrow keys, one can easily switch between months and thus display data from previous months. A specific month can also be selected directly from the drop-down menu.

• FB

Booking indicator - additional information at the beginning of the booking (e.g.: core time violation, booking out of frame, ...). If the mouse is moved over the question mark icon, a small message appears with the reason for the marking.

• Bookings

Used to display the booking intervals.

• FE

Booking indicator - additional information at the end of the booking (e.g.: core time violation, system go, ...). If the mouse is moved over the black question mark icon, a small note appears with the reason for the flag.

Absence reasons

If the employee books an absence reason (e.g. doctor, business trip, holiday, sick, ...), this information is displayed in this column.

• Target time

Display of the daily target time

• Work time

Display of the actual daily working time

• Sum

The sum of the total hours worked in this month

• Time Balance

The sum reduced by the sum of the target time - the time balance can also be negative

• Automatic break deduction

If no break or a break of less than 30 minutes is consumed on a day, the break time is automatically deducted by the system (the system adds 30 minutes).

If there is no booking on a day and no absence is planned, the message " **Absent without excuse**" appears in the journal. For negative time recorders, the administrator can specify under which conditions this entry is to appear or not, under Persons --> Select corresponding person --> Tab "Modules" --> "Negative time recorders: Auto generation actual time".

Practical functions

By clicking on the **double arrow** below / next to the date entry, a menu can be opened to directly start a time correction / absence request for the day.

In addition, it is also possible to submit a time correction / absence request for the selected day by right-clicking on the corresponding line in the journal.

K: The info symbol and the adjacent 3 indicate that **3 corrections** have taken place on this day. You can find out which corrections these are by clicking on the info symbol.

FB: The question mark symbol indicates that there is additional information at the beginning of this booking (in this case: core time violated).

Bookings

- **Times highlighted in blue** mean a "manual" correction of the time, for example via a **time correction** request.
- Black times indicate a regular booking (via the Book item).
- **Green times** are postings made **automatically by the system** in this case, the employee has not booked out on this day and the system has therefore generated an automatic posting that corresponds to the end of normal working time.

FE: The question mark symbol indicates that there is additional information at the end of the booking (in this case: system exit).

Absence reasons: Indicates that an doctor's visit has taken place from 11:00 - 12:05.

Target time: Indicates that 7:42 work should be performed on this day.

Worktime: Indicates that 10:52 was actually worked on this day.

Sum: Results from the actual time hours worked on the considered and the previous days of the current month (i.e. from 01.06. to incl. 04.06.2021 26:42 hours actual time were worked).

Time Balance: Total of the difference between actual time and target time in hours from the employee's creation to the day in question (= flextime balance).




Automatic break deduction: Shows that 3 minutes (0.03) of break time have been deducted for this day.

5.3.3 Calendar

General

The **absence calendar** is used for planning and overview of full-day and half-day absence reasons (holiday, training, illness,...).

Approved absences are shown in black / unapproved absences are shown in red. Light blue marks the current day, Saturdays are light orange, Sundays are orange and the days marked in green are public holidays.



The arrow buttons can be used to scroll one year forward or backward.

As long as an absence / special absence request is in progress (status unapproved), the absence is already entered in red in the calendar.



After a request has been approved, the absence appears in black on the days concerned. All work-relevant data is updated (e.g. remaining leave or planned leave).



By clicking on the U field in the calendar, you can obtain detailed information on the request (examples of an unapproved and approved absence request):






Practical functions

By clicking on the **double arrow** below / next to the date entry, a menu can be opened to directly display the journal for the relevant month.

It is also possible to **right-click** in the corresponding cell of the calendar to make a time correction/absence request for the selected day or to open the journal for the selected month.



The calendar view can also be exported as PDF or Excel or prepared for printing. The corresponding symbols (Print, PDF, Excel) are located in the upper right corner.

5.3.4 Group calendar

General

Via the **group calendar**, the user is shown all planned and consumed full-day and half-day absences of a defined group of persons (usually his department).

This view is intended to ensure smooth leave and absence planning within a defined group of persons (department).

Unauthorized absences are displayed in red and approved absences in black.

The user can query the group calendar using the **time unit** week / month or the **specified period** (displays the desired month). The month can be changed with the arrow buttons.

In the group calendar, each staff member sees the colleagues from his or her department or, according to his or her viewing authorisation, also colleagues from other departments.

General

The **attendance list** shows the selected groups, the names of the persons assigned to the group, the status (green tick for attendance, red cross for absence, absence reason), information about the last booking, in the case of absences also the duration of the absence



(e.g. business trip, holiday, ...). Via the search mask, the user can query the attendance/ absence of employees based on various criteria.

Grouping

This parameter allows you to choose between: No grouping, 1st level, 2nd level, 3rd level.

- No grouping: all users are displayed in alphabetical order.
- **1st level**: all selected groups and users are grouped below the 1st node and then displayed.
 - Example:
 - Selection of group PB --> Employees are displayed under PB, since PB is the highest node in the organizational chart.
- **2nd level**: analogous to the 1st level all users below the 2nd node are displayed here.

Filter

You can use this parameter to search according to the following criteria: only present, only absent, only missing reason, no restriction.

- only current present persons > only present colleagues are displayed in the attendance list
- only absent persons > only absent colleagues are displayed
- **only persons with absence reasons** > only colleagues who have posted an error reason (e.g. off-site work, sick leave, vacation, etc.) are displayed here.
- **no constraints**> all colleagues are displayed for whom you have access authorization.

Output format

If this parameter is set to print version, you get a print-friendly output of the list.



Selection tree

This parameter offers the following selection options: Groups with access authorization, All groups.

- Only authorised groups: Displays all groups that the user has access to.
- All groups: displays all groups of the company, even if the user is not authorized to view them all.

Search

If a search term is entered, the system searches in all groups for which access authorization exists. It is possible to search for a complete name (surname, first name) or for a part of the name. The result then contains all possible surnames as well as first names and is highlighted in color.

Consider selection in search

In principle, all groups for which access authorization exists are searched when an entry is made in the **Search** field.

If this option is checked, only the groups selected under **Selection** will be searched.

Show result if possible

If this option is activated, the selected search settings are saved and the result is displayed immediately when the attendance list is called up again.

Selection

With this parameter, the user has the choice between organigrams and favorites, which can be created by the user himself.

• Organigram

- All folders marked with a plus (+) symbol can be expanded further to show the subunits.
- By clicking on a unit, it will be checked. By **double-clicking**, all subunits are automatically checked.
- by clicking on the green arrow > Show subgroups to depth (depth 1-3) > all existing subgroups are displayed
- using the blue arrow > Minimize tree > this view is minimized again, only the parent groups seem to be on
- Show details > By clicking on the symbol symbol groups are clearly displayed in a list to the right of the symbol. Click again to hide the detailed information.
- Clicking the query button starts the **search**.
- Favorites



Using this parameter, each user can create their own favorites list, which can contain both persons and groups that are frequently queried. The Favorites list can be customized at any time.

This is the message that the employee can enter when **booking** (optional) (for example, when an off-site work is posted): off-site work company XYZ - reachable on mobile phone).

• Last booking

Shows when the last booking was made.

Absence reason

Example: Vacation, sick leave, off-site work

• from - to

Absence period for leave, sick leave, off-site work,... - A special feature is the specification "**b.a.w.**", which only appears in connection with the error reason "**Sick**". "**b.a.w.**" stands for "**until further notice**" and is entered if it is not clear when the employee will be able to work again. This error reason is automatically posted by the system every day until the employee posts again for the first time.

The summary contains information about the number of employees displayed.



5.4 Requests

5.4.1 Time correction

General

Time correction requests are used to made bookings that have been forgotten, missed or not made due to other circumstances.

The user must enter the date and time of the correction booking in the form.

If time has to be booked in past, the **absence reason "present"** must be entered. The comment field can be used for comments for the approver (supervisor). The comment will later appear together with the request details in the Uncompleted Requests (page 68) list (to be found under the menu item Workflow) for the applicant and in the Open ToDos¹ list for the approver (supervisor).

Possible reasons for a time correction are:

- Present (e.g.: in case of forgotten booking at the beginning of the working day)
- Doctor's visit
- Business Trip
- Telework
- Various absences

The button "Show Journal" serves here as a possible help for filling out the request.

The request procedure is started by clicking on the "**Start Process**" button and the request is sent to the supervisor for approval. The supervisor finds the time correction request under the menu item **Workflow** - Open ToDos (page 66).

5.4.2 Cancellation of time corrections

General

Cancellation of time correction requests are used to **delete incorrect attendance times** from the system. This means that an employee who, for example, has forgotten to book the lunch break, can book it in retrospectively via a cancellation of time correction request.

An example: an employee works from 08:20 to 16:40 and was on lunch break from 13:00 to 13:30 - but forgot to book it. So he calls up the cancellation of time correction request and enters the corresponding date and time span (13:00 - 13:30). Since no approval by the supervisor is necessary, the change is immediately visible in the journal after clicking on "**Start process**".

The user must enter the date and time of the adjustment entry in the form.

The only possible absence reason is Absent, since an incorrectly booked attendance is to be corrected.

For other time corrections (doctor, business trip, various absences, telework) the menu item Time correction must be used!

If necessary, a note can be made in the comment field as to why the time had to be corrected (e.g.: forgot to book lunch break).

5.4.4 Cancellation of absences

General

Cancellation of absences requests are used to delete incorrect full-day or half-day absences (holiday, time compensation, ...) from the system. This means that an employee who, for example, wants to cancel his or her requested and already approved holiday can subsequently remove this request from the system using a **Cancellation of Absences Request**.

An example: An employee has an approved holiday from 27/07 to 31/07. - but cannot consume it. He or she therefore calls up the Cancellation of Absences Request and enters the relevant date (from 27/07 to 31/07). Since no approval by the superior is required, the change is immediately visible in the system after a click on "**Start process**".

The user must enter the From and To date (from 27/07 to 31/07) in the form.

The only possible absence reason is "Present", since a full-day or half-day absence is to be cancelled.

If necessary, a note can be made in the comment field, to explain why the absence had to be cancelled (e.g.: postponement of holiday).

The actual special leave entitlement in days for e.g. marriage, death, birth, change of residence, etc. depends on the respective collective agreement and cannot be fixed as a general sum!

As support, the user can **show his calendar** to get an overview of his own annual planning. Furthermore, the **group calendar** can also be displayed, which provides an overview of the planned absences within the department.

The calendar / group calendar can be hidden again by clicking on the button "**Hide calendar**" / "**Hide group calendar**".

The sick note is used to report a colleague sick. It is important to note that sick leave can only be registered for the current day and the previous day. For sick days longer in the past, an Absences request (page 56) must be submitted.

5.4.7 §20 AZG Special cases

General

According to the *Austrian working wours act*, the maximum daily working time is currently 12 hours. Exceeding this maximum working time is only permitted in justified exceptional cases (see §20 of the Working Time Act²).

Note: in exceptional cases where this rule cannot be complied with, this has to be reported to the labour inspectorate in written (within 4 days)!

Therefore, the time in Personalwolke that exceeds this limit is capped (cut off) by default and shown as unvalued time in the journal.

With the help of the request **§20 AZG Special cases**, this unvalued working time, which had to be performed due to a valid case of exemption, can be reclaimed.

the date for which the maximum daily working time may be justified

- **Comment** Reference should be made here to the nature of the exceptional case
- Daily working time Depending on whether the request has already been approved or not, the capped or uncapped real time appears here

If the daily maximum working time is exceeded, the journal shows the following:



5.5 Workflow

5.5.1 General information

The menu items, which are combined by the **Workflow** menu bar, serve to track the progress of your own and assigned requests, as well as an archive for completed requests and completed tasks.



This document demonstrates the **operation of the filter function** and the **history view** using the example of "Uncompleted requests (page 68)". However, the same options are also available under the other menu items of this sub-item.

• Author of Process

Here you can search for a specific applicant > selection of the desired person (process author) from the list of names.

• Group

With this parameter you can select a specific group (e.g. management or marketing), or search in all groups.

• Process

Search for a specific process (for example, all vacation requests of a desired person > Process vacation). If you want to see all requests, select "All processes" as parameter

• Creation date from / to

Search for requests with a specific creation date (it is possible to enter either from - to date, or for example only to date to see all requests submitted up to a specific date)

• Effect date from / to

All applications whose validity period is valid from the from date are displayed. In addition, you can limit the effective date with the to-date parameter.

By clicking the "**Apply Filter**" button, the applications are searched and displayed according to the parameters.

If you do not want to have the filter criteria on the screen, click on the "Hide filter" button.

If you do not want the column with the process history to be displayed in the application overview, click on the "**Hide Progress**" button. If you want to see the column again, select "**Show Progress**".

5.5.2 Open tasks

General

For **decision-makers (managers, personnel)**, this menu item is used to process assigned requests.



Example: Person A is the manager of person B. Person B makes a Time Correction (page 53) request. Person A sees this request under the menu item Open ToDos (since person A must approve or reject person B's request). Person B sees the request under the menu item Uncompleted requests.

There are 4 options to choose from when processing applications:

- Approve to approve the request
- Deny to reject the request
- Comment to add a comment
- Forward to reassign the request to another staff member
- Print to create a version optimised for print output with all the information related to the request
- Cancel to cancel the request without deleting it
- Delete to delete a request

Depending on your role and permissions within the system, not all options may be available to you. For example, the "Approve" option will only appear for supervisors who are authorised to approve leave requests.

The view is essentially the same as that of the Open ToDos (page 66), with the difference that only **completed requests** are displayed in the completed tasks that can no longer be processed further. This view is a kind of archive that only serves to document the completed tasks.

5.6 Administration

5.6.1 Authorization concept

Permission concept in **Personalwolke Time** is implemented by assigning of users to "loose groups". Depending on the assignment to loose groups the permissions of the users can be changed from standard time attendance (basic user interface) to additional management reports or administrator functions. The number of loose groups can be customized to special requirements of the customer. Nevertheless, every **Personalwolke Time** customer has to consider three types of loose groups:

Of course it is also possible to add a user to all loose groups and thus unlock the administration AND management menu items to the user or a simple standard user is created which is only added to the loose group PB-ALLE.

The menu item Time management --> Correction client represents a special case. Only persons who have assigned the Personnel role can use this correction client (regardless of the loose groups to which they have been added) to change bookings. In some cases Corretion client is also used by standard users to track time: this option requires an assignment of the user to standard loose group PB-ALLE.

5.6.2 Organigram

General

The **organizational structure** allows the client (company) to be divided into groups (departments), and is the top organizational element for all groups that have the same type. This is usually referred to as **hierarchical structures**, such as the organizational chart. The hierarchical structures play an important role in the query of various lists and representations (e.g. query of an attendance list, management lists, ...). However, it is also possible to create organizational structures which have no hierarchical relationship to each other, so-called **loose groups** (see Permission concept (page 70)).

An organizational structure has one of the following organizational types assigned to it:

Hierarchical organizational structure



Loose Groups

The **hierarchical organizational structure** is represented in an organizational chart of the enterprise (client). This hierarchy determines the relationships between the groups (departments). You can define a top group (department) in the organizational structure (for example, executive board). In addition, higher-level or lower-level groups (grouping in the menu option Groups) determine the appearance of the organizational chart and the relationship between the groups.

One person can only belong to **one hierarchical group** at a time (but can also be a member of various loose groups)!

The organization type "**Loose group**" is used for groups without a systematic organizational purpose. Loose groups do not have a hierarchical relationship between the groups. Examples of such groups result from the necessity of individual application modules to group employees according to various criteria, such as All-inclusive lists, All male employees, All apprentices, and so on.

One employee can be assigned to several loose groups.

Representative

- The next higher manager is the next logical representative for a manager, if there is no explicitly nominated one.
- A manager should not be able to approve his or her own proposals and a deputy subordinate to him or her should not be able to do so.

Yellow marked is the name "Golf Rolf" because of the search term "Golf".

5.6.3 Employee administration

General

The person administration includes all evaluable employees of the company as well as all users of Personalwolke. These two sets of persons do not necessarily have to be congruent.

However, each person who is to be evaluated using the authorization structures of the Personalwolke must exist as a master record in the Personalwolke.

Depending on requirements, all active employees as well as employees who have left the company can be managed here.

The person master data fulfill 2 functions:

- enable access to the Personalwolke (access to the Personalwolke is only possible for active users).
- The employee can be evaluated (employees who have left the company can also be taken into account here).

All person master data is entered and managed in the person administration, such as user name, personnel number, which group (department) the employee is assigned to, which roles he or she holds, and who is responsible for this employee (superior, personnel). Passwords are also managed here.

New group assignments can be made here as well as the assignment of new roles.

An employee can only be assigned to one hierarchical group at a time, but to several loose groups!

Active / Inactive Employees

A differentiation can be made between active and inactive employees.

Active employees are all employees with Personalwolke access, they are fully evaluable. Nonactive employees do not have access to the Personalwolke, cannot be reached via the Switch user (page 97) user switching function, but can be fully evaluated. Non-active employees can be, for example, employees who work in a production hall and do not have a fixed workstation or PC. Here, time recording and corrections can be carried out by a superior person (e.g. shift, team or plant manager, etc.).

Employees are identified as active or inactive in the person master data sheet (page 77).

New entries / Resignations

The creation of **new employees** is done directly in the Personalwolke via the menu item **New Person**. New employees can be marked as active or inactive when they are created.



The following options are available for **employees who have left** the company:

- Employee is deleted directly in the Personalwolke Please note that the deleted employee can not be evaluated!
- Employee is marked as inactive Due to the inactive status, an evaluation license will be calculated for this user. The inactive employee remains evaluable in his former group, but can no longer actively login into Personalwolke, or there is no Switch user (page 97) user switching option to the inactive employee.
- Employee is moved to a leaving group

If an employee who has left the company is moved to a leaving group, his or her status should be set to inactive. This means that the effects are the same as for inactive employees. The **advantage** here is that the leaving employee no longer appears in his or her original group, or if this group is deleted, the leaving can still be evaluated.

It should be noted here that the legislator intends to archive the data for a certain period of time. The Personalwolke automatically takes care of this point and no intervention on your part is necessary.

Historization

The historization of the employee data refers only to the evaluation possibilities, and is meant to consider left employees and group changes. This guarantees the possibility of a historically correct group assignment for department changes.

This list can be sorted in ascending or descending order using the blue triangles and according to various criteria (last name, first name, group, user name, personnel number, TA-ID, active, valid from).

In addition, the white text fields at the beginning of the list offer the possibility to restrict the displayed data records according to various criteria, e.g.: Last name "gs" shows only persons whose last names contain "gs" (enter gs in the text field and start search with Enter / Enter key / click the Magnifying Glass-Symbol). To make all records visible again, simply delete the search term from the corresponding field and press Enter again.

E-mail notification controls whether the user should receive an e-mail when new requests for approval / review are received.



E-mail notification as a deputy analogous to the point E-mail notification, only from the viewpoint of the deputy

Activates / deactivates the deputy regulation, i.e. the deputy is authorized / not authorized to approve proposals.

E-mail the e-mail address of the user to whom the notifications will be delivered.

As already mentioned, the other fields are optional and self-explanatory.

Once all fields have been filled in, the person can be created by clicking on **Save**. The successful saving is confirmed with a corresponding message (person 'Mustermann Max' was saved successfully!). Only **now** can the password for the user be reset to the default password (=user name) by clicking the **Reset password** button. This must be changed when the user logs in for the first time.

Password-Management

After saving a person, the password of the user can be reset to the default password using **Reset Password**.

Note: The **default password** corresponds to the **user name including prefix** (case sensitive!) and must be changed after the first login!

Here you can see that the selected user is currently assigned to the group PB-AGB1 (Geschäftsbereich 1) in the organization chart PP. With **Valid from** and **Valid to**, you can define a period in which the person is assigned to a particular group. Under **New Group**, you can select another group and define a time period for the validity of the group membership. The check mark at **with past** determines whether expired (past) group memberships should also be displayed in the list of group memberships.

As an example: Mr. Müller works until 02.05.2013 in the PP-ENTW group and is to belong to the PP-AGB1 group from 03.05.2013. To realize this automatically, the Valid until date can already be changed to 02.05.2013 and the group PB-AGB1 with Valid from 03.05.2013 can be saved under new group. Thus the group change takes place automatically on the specified key date.

Note: A person can only be a member of one hierarchical group at a time!

Loose Groups

Under **Loose groups** you can define the affiliation to several non-hierarchical groups. The number of loose groups to which the employee can be assigned is unlimited.

- **New role assignment** Selection of the role through clicking on the 3 horizontal dots (manager (Vorgesetzter), personnel (Personal) to be assigned to the employee.
- **Competence target** refers to the person/group for which the employee is to be responsible.
- Valid from / Valid to describes the period in which the employee is assigned the selected role.
- The **order** determines the deputy (sequence 1 = superior, 2 = deputy, 3,4 = if several persons are defined as deputies, the system determines who receives an application for processing).

Example: New role assignment "Vorgesetzter", competence objective: group, "PB-ENTW (development)" - this means that the person performs the role of superior for the group PB-ENTW, i.e. all applications submitted by a person from the group PB-ENTW and requiring approval / review by the role of superior end up with this person. Of course, a special person could also be appointed instead of the group. In this case, the Superior role only applies to the person who was defined.

A person can be assigned several roles with different competence goals!

Explanation of the individual table columns:

• Indicator

The complete registration number of the registered vehicle must be indicated here.

• Type

In this dropdown element, a distinction must be made between passenger cars, motorcycles and trucks.

• Brand

The car / motorcycle / truck brand must be entered here by direct input.

Model

Optionally, the model can also be entered here for specification in addition to the brand.

• Number of seats

Here you have the possibility to indicate the number of carpooling opportunities.

• Fuel

In this field, you can enter whether the vehicle is powered by petrol / diesel / electricity / biofuel / etc.

• Valid from and Valid to

These mandatory fields must be used to determine how long the vehicle is visible in the Mileage allowance tab of Travel Expenses.



After filling in this form, the entry must be accepted by clicking on the **Save** button. Any number of vehicles per person can be added. By clicking the Bin Symbol (next to the **Valid to** field), added vehicles can be removed again.

Groupware

If the optional **groupware module** has been ordered, you can check if the connection to the groupware system (currently **Microsoft Exchange**, **LotusNotes** and **ZIMBRA** are supported) is working. No changes can be made - this tab only provides a status view.

Time recording

In order to **activate time recording** for the user, the check mark for Activate time recording must be set in this view. Afterwards one of the preset **weekly programs** must be selected!

After checking the box and selecting a week program, the settings are saved with **Save**.

5.6.4 Groups

General

A group allows several persons to be grouped into organizational units, which can serve different grouping purposes in the context of the employee portal:

- department
- team
- area

The assignment of the group to the organizational structure indicates whether the group is a hierarchical organizational unit (referred to in the personnel cloud as "organizational chart XXXX", where XXXX corresponds to the client abbreviation) or a loose group.

Hierarchical Group

If the group is part of a hierarchical organizational plan (organizational chart XXXX), additional relationship options to other groups are available: These relationships to each other are regulated, for example, by determining a "top group in the structure" or a higher-level or lower-level group.

If a higher-level group is selected, all other groups in the organizational chart appear subordinate to this group. A higher-level group can have several subgroups.

Loose Groups

The non-hierarchical (loose) groups are groups without a systematic organisational purpose, i.e. these groups do not have hierarchical relationships with each other that allow employees to be grouped according to various criteria (e.g. full-time employees, part-time employees, flat-rate employees, departures, maternity/paternity leave, projects, etc.). Employees can be assigned to several loose groups at the same time.

Depending on the account type (TimeFree, TimeBase, TimeProfessional), loose groups are created in the personnel cloud by default from the beginning, via which the possibilities of the employees assigned to them are controlled.



TimeFree

- XXXX-ALLE Basis group to which all employees must be assigned
- XXXX-Management Group, the employees who are to receive extended rights (person/group administration, correction/absence client, various evaluations and statistics).

TimeBase & TimeProfessional

- XXXX-ALLE
 - Basis group to which all employees must be assigned
- XXXX-Management Group for employees with extended rights (account evaluation, absence calendar, statistics)
- XXXX-Admin

Group for employees with extended rights in client administration (organization chart, person administration, group administration, role administration, user switching)

Each employee MUST be added to group XXXX-ALLE (where XXXX stands for the respective fixed client abbreviation).

By adding to one or both other loose groups, additional rights can be granted to the employee.

Group membership and group change

Members of groups are persons. For hierarchical groups, one person must be assigned to exactly ONE group at a time. If a person is assigned to a hierarchical group, this person loses membership of his or her previous hierarchical group.

If the group is a loose group, persons can be members of several such groups at the same time!

The assignment of employees to a group can be planned in advance by determining the validity date of the respective employee in a group. For example, you can plan that an employee assigned to group A is to be assigned to another group (group B) from a certain date (valid from - to).

Roles

Roles can be assigned to groups created by the user. All employees in this group are then the owners of the assigned role(s) (Manager, Personnel).

To make all records visible again, simply delete the search term from the corresponding field Maginfying Glass-Symbol and press Enter again.

Organizational structure determines whether the new group is to be integrated into the hierarchical structure (organizational chart XXXX) or whether a lot group (lot groups) is to be created.

Short name means the abbreviation of the new group incl. fixed prefix (e.g. SUP for support). **Name** is the freely selectable meaningful name of the group.

Description is a description of the group (optional).

After a click on Save the group is created and further settings have to be made in the tabs **Parent group, Subgroups, Roles, Persons, Action permissions, In the competence area of these role owners**.

The check mark at **Highest level** [*ONLY for hierarchical groups*] must be set for exactly 1 created group. This then represents the topmost group (root) in the organigram. All other groups are subordinated to it.

With **Valid From** and **Valid To**, this integration can be limited in time, for example, if the group has only 1 employee with a limited contract. The checkbox **with past** is used to display expired group assignments if desired. With a click on **Save** the changes are accepted.



It is also important to mention that a hierarchical group can only have exactly one other hierarchical group as a direct superior group!

Subgroups can be used to define those groups that are to be located below the current group in the hierarchy of the company. Please note that the groups added in this tab are **automatically assigned to the current group as the parent group**. Under Roles, the group can be assigned a certain role (supervisor, personnel), which is then assigned to all employees added to the group. To do this, click on **Role assignment**.

Under **Role** you select the appropriate role by clicking on the 3 horizontal dots (in this case Personnel). Under Competence Objective you can select a **person** or a **group** for which the current group should perform the selected role.

An example: If you select Personnel as role and Person as competence target, the current group is responsible for the selected person XYZ in personnel questions. This means that all members of this group are responsible for personnel questions concerning person XYZ.

With **Valid From** and **Valid To**, you can define a validity period for the role assignment. A click on **Save** saves the settings.

5.6.5 Roles

General

A role describes a specific function within a company (superior, personnel).

A role in the personnel cloud essentially serves 2 functions:

- On the one hand, access authorizations for individual program functions are realized using roles.
- On the other hand, they fulfill certain functions in the workflow flow (for example Supervisor: Approval of leave requests, personnel: Views of sick leave notifications)

In the personnel cloud there are 2 predefined roles that can be assigned to individual persons or groups:

• Manager

As the name suggests, this role is used to grant a person or group certain extended rights to approve or reject requests made by employees (vacation, doctor, time compensation, etc.).

Personnel

This role helps you evaluate employees. Various evaluations can be created for different topics (accounts, sick days, holidays, statistics, attendance, etc.).

You **assign the role** either using the role itself, the **person master data sheet** (page 77), or a group (page 90).

The role also performs certain functions during the process flow (requests). Here, the role holder can set defined activities, such as approving, rejecting, or viewing a request (see open tasks (page 66)).

In contrast to organizational structures (groups, loose groups), a role **cannot be evaluated**. This means that no information functions of a role can be taken into account when information is queried. To make this possible, the role holders would have to be combined in a loose group (for example, a loose group of superiors to which all holders of the role managers are added).

Competence target

A **competence target** is defined as a person or group for which the role holder is responsible or which may be inspected.

Here there are 3 possibilities: certain PERSON(s), certain GROUP(s) or CLIENT. A simultaneous assignment of several competence goals is possible.



Assignment of a role to a person

You can assign a role to an employee by choosing **Roles** in the menu.



To assign a role simply click on the edit icon. In the following overview you will find a list of the competence goals and role owners of the selected role.

In this example it can be seen that the PB-SUP group performs the role of personnel for the person Honig Helga, i.e. all persons assigned to the PB-SUP group perform the role of personnel for the person Honig Helga. In addition one sees that the person Gschaftig Gunter takes over the role personnel for the entire enterprise (client) personnel cloud Base.

With a click on **New Role Holder** the selected role can be assigned to new persons / groups.

- **Competence target** refers to the person / group for which the employee is to be responsible. In addition, it is also possible to select a client, whereby client refers to the entire company.
- The role holder can be a person or a group.
- Valid from / Valid to describes the period in which the employee is assigned the selected role.
- **The order** determines the deputy (order 1 = superior, 2 = deputy, 3,4 = if several persons are defined as deputies, the system determines who receives an application for processing).



Practical functions


- When assigning a new role to a person/group/client, there is also the option of using an AutoComplete function. This function is activated by starting to type in an empty text field where, depending on the selected competence target / role owner, corresponding options are displayed or, if only one option exists, it is selected immediately.
- We select competence target "Group" and enter "PP-" in the newly appearing text field. While you are still typing, a list of options appears from which you can choose. The arrow keys can be used to scroll through the list of results or to select a suggestion with the mouse.
- We select the person as the role owner and type "Ren" in the input field. Since there is only one employee whose name begins with "Ren", the AutoComplete function immediately writes the entire name into the field.

A click on Save stores the settings.



• Validity of the daily program: The validity of the daily program indicates from when to when a day is valid.

Example: A validity of 00:00 to 24:00 indicates that a day is valid from 00:00 to 24:00. If a daily program should have a validity from 06:00 to 05:59, this would mean that overtime and times within the frame of 00:00 to 05:59 are attributed to the previous day. Also, a daily program automatically ends with the validity and books out the employee.

Note: In the tab Credit - "Credit in case of missing booking" you can define how the programme should behave if the employee has not logged out by the end of the validity of the daily program (e.g. because the employee has forgotten to log out).

• **Frame time for time recording:** This time frame indicates when the employee's bookings are evaluated as working time. Times outside the frame are unvalued working times.

Attention: For this you have to activate the parameter "Work out of frame" if you want to work with a frame time.

• Normal working time: This is the normal working time of the daily program.



- **1st Core time:** Here you can store a core time. If a core time has been stored in a daily program, the program throws an irregularity if this core time is violated. You can see this in the correction client in the FB and FE columns.
- 2nd Core time: You can store a second core time here if you need one in your company.

- **Rounding booking:** For this, please contact a Personalwolke consultant. This function is not enabled by default and is only used for special regulations.
- Amount for absence correction: please adjust all amounts in this table to the target time!
- Bonus:

1.Credit if going booking is missing: Here you can set how the system should behave if the employee does not book out. Note that this only has an effect if the staff member has not booked out by the end of the validity of the daily program!

You have the following setting options here:

- till frame time end: The end of the frame time is taken as the last booking.
- till core time end: The end of core time is used as the last booking.
- till normal work time end: The end of normal working hours is taken as the last entry.
- No credit: The employee's last booking is used as the last booking.

Example: An employee books in at 12:15 and forgets to book out. The system will then close this booking with 12:15, so that no credit is created here. The employee must correct the times afterwards by means of a time correction request. It is recommended to use this setting!

- **until going time from daily program :** The time that is stored in the setting "Last going booking" is used as the last booking.

- completion up to daily target time: If the employee forgets to book out, the booking is terminated with the time with which the employee would reach the daily target time.

2. Last going booking: Here you can enter the time for the setting "To go time from the daily program" of credit in case of missing go booking.

3. Way time credit: a credit that is credited to the employee each day. For example, a travel time credit of 5 means that 5 minutes are credited each day.



4. Overtime treshold 1:indicates from when the employee can work overtime. If, for example, 8:00 is entered here, this means that the employee can only work overtime from the 8th hour.
Example: Overtime threshold = 10:00. If the employee works more than 8:00, the time up to the 10:00 hour is always evaluated 1:1, even if the employee has an authorisation for overtime and is in a time frame in which overtime can occur.

5. Overtime treshold 2: indicates the daily maximum working time. If the daily 10h capping is active, the time is capped to this value here.

Example: Maximum working time = 12:00 and Daily 10h capping is active. The working time of the employee that exceeds 12 hours on that day moves to the background account for unvalued hours. Thus, a 12-hour cap takes place.

Accounts

Here you can select a template to store overtime in a daily program.

Note: If you do not need an overtime calculation, you can skip this point.

This template grants 100% overtime in the period from 00:00 to 06:00 and from 22:00 to 24:00. In the period from 06:00 - 22:00 the day programme grants 50% overtime. These overtime hours are not counted until the overtime threshold (see credit) is reached.

This template grants 100% tax-free overtime in the period 00:00 - 24:00. These overtime hours are only valued when the overtime threshold (See Credit) is reached.

• 100% Üstd 00:00 – 06:00, 100% Üstd 20:00 – 24:00

This template grants 100% overtime in the period from 00:00 to 06:00 and from 22:00 to 24:00. These overtime hours are only counted when the overtime threshold (See Credit) is reached.

• 50% Üstd 00:00 -24:00

This template grants 50% overtime in the period from 00:00 to 24:00. These overtime hours are not counted until the overtime threshold (See Credit) is reached.

Example Adjust accounts:

It is best to use the template here, 100% Üstd 00:00 - 06:00, 50% Üstd 06:00 - 22:00, 100% Üstd 22:00 - 24:00"

Then adjust them as follows:

- First delete the "Konto TP 50% p. Vor" by clicking on the small red bin. You no longer need the account.
- Next, adjust the beginning and end of the accounts.

If you then save, you have successfully made the change for the daily program.

Account designations

There are the following accounts depending on the template:

- **TP 10h Kappung:** If this account is stored in a daily program, there is a 10 or 12 hour cap for the daily program. However, for this to have an effect, it must be activated for the employee.
- **TP 50% p. Vor:** This account specifies the period in which 50% compulsory overtime can accrue. "Vor" stands for the period before normal working hours and should be used as such.



Example: Start at 06:00 and end at 08:00 is stored with "TP 50% p. Vor". The overtime threshold is 0. If the employee works from 07:00 to 09:00 on that day, he/she will receive 1 50% compulsory overtime, provided that the overtime calculation has been activated for the employee or he/she has received the UE authorisation for the day through the correction client.

• **TP 50% p. Nach:** This account indicates the period in which 50% compulsory overtime can be worked. "Nach" stands for the period after normal working hours and should be used as such.

Example: Start at 08:00 and end at 22:00 is stored with "TP 50% p. Nach". The overtime threshold is 8. If the employee works from 08:00 to 18:30 on the day, he receives 2 50% compulsory overtime hours for the time from 16:30 to 18:30, provided that the overtime calculation has been activated for the employee or he has received the UE authorisation for the day through the correction client.

• **TP 100% p. Vor**: This account indicates the period in which 100% compulsory overtime can be worked. "Vor" stands for the period before normal working hours and should be used as such.

Example: Start 00:00 and end 06:00 is stored with "TP 100% p. Vor". The overtime threshold is 0. If the employee works from 05:00 to 07:00 on the day, he/she receives 1 100% compulsory overtime, provided that the overtime calculation has been activated for the employee or he/she has received the UE authorisation for the day through the correction client.

• **TP 100% p. Nach:** This account indicates the period in which 100% compulsory overtime can be worked. "Nach" stands for the period after normal working hours and should be used as such.


Example: Start at 22:00 and end at 24:00 is stored with "TP 100% p. Nach". The overtime threshold is 0. If the employee works from 21:00 to 23:00 on the day, he/she receives 1 100% compulsory overtime, provided that the overtime calculation has been activated for the employee or he/she has received the UE authorisation for the day through the correction client.

• **TP 100% f. Nach:** This account indicates the period in which 100% free overtime accrues.

Example: Start 00:00 and end 24:00 with "TP 100% f. Nach" is stored. The overtime threshold is 0. If the employee works from 07:00 to 09:00 on the day, he gets 2 100% free overtime hours, provided that the overtime calculation has been activated for the employee or he has received the UE authorisation for the day through the correction client.

Saving a daily program

The following options are available with regard to the daily program:



If you change and save a day programme, then you have two options if the day programme is already assigned to staff members:

- **Copy**: Copies the day programme 1:1 and creates a new one. This can then be used in the weekly programme instead of the old day programme. The reason for copying is that there is a clear demarcation from the old daily programme.
- Save and re-run daily accounting: Saves the changes and calculates all employees who have this daily programme back to the day on which this daily programme was run for the first time.

ATTENTION: Since the calculation is done backwards, the values in the past may change! If you do not want this to happen, you must use the Copy option to create a copy of the day programme. This can then be changed and assigned to the weekly programme.

If the day programme has not yet been assigned to a staff member, the day programme is simply saved.

By the way, with **Save & Archive** you can remove day programmes that are no longer needed from the list of day programmes.

The action "weekly programs" is used to create weekly programs.

In the column **"Client"** you can see to which client this week program is assigned. If the column is empty, then it's a standard weekly program from Personalwolke, which is available to all but can't be edited. Every weekly program is assigned an **ID** by the system. This ID cannot be changed.

With "weekly program(s)" you can see how many week cycles this weekly program contains. For example, if there is a 2, this means that this weekly program has 2 week cycles. The week hours of the respective weekly program are shown in the column **"with these hours per**



week". If a weekly program has multiple week cycles, then you will see the respective week hours of the week separated by a comma.

Basic info: A weekly program consists of several daily programs. There must be one day program for each day of the week, i.e. Monday, Tuesday, Wednesday, Thursday, Friday, Saturday and Sunday. In addition, holidays such as Christmas, New Year's Eve and public holidays must also be taken into consideration.

If you click on the button "**new weekly program**", an editor will open where you can create a new weekly program.

• Select a template

The daily programs are also deposited in the template. Change these as desired. In fact, that the holidays are already shown in the template, you save a lot of time.

- Enter a "short name" and a "long name" for your weekly program.
- The hours per week are calculated automatically by the system based on the day programs that are deposited in the weekly program.

First select a **day target time**. The system will show you in the colum "daily program" all daily programs which contains this day target time.

Now it is necessary to fill all the other days in the weekly program. Here an example how to create a 38:30 weekly program:

Here you can choose from the following days:

Here you define which daily program has to be used if a holiday is on a Monday, Tuesday, etc. If you do not deposit any holidays in the weekly program, the program will take the working day as a holiday, which is deposited in the tab "Daily programs for working day, saturday and sunday".



Example: Monday is a holiday and there is no "holiday Monday" deposited in the weekly program. In this case, the system uses the normal daily program for Monday on the holiday. If the daily program has a target time of 08:00, then the employee in this case would have a target time of 08:00 on the holiday. Therefore, a corresponding daily program should also be deposited for each holiday.



Once the weekly program has been assigned to a staff member, you have two options:

- 1. **Copy:** Copies the weekly program 1:1 and creates a new one. The reason why you should copy the weekly programm is, that there is a clear distinction from the old one.
- Save and rerun daily account: saves the changes and calculates all employees who have this weekly program back to the day on which this weekly program was run for the first time. ATTENTION: Because of the retrograde calculation, the values in the past can change!

If the weekly program is not yet assigned to an employee, then it's simply saved.

By the way, you can use "**Save & Archive**" to remove weekly programs that are no longer needed.

5.6.7.3 Correction-Client

General

The **booking and absence time corrections** serve the recording of **time bookings or absence times in hours**, as well as the **correction** of already existing bookings.

The recording can be done in a **monthly** or **daily view**.

Important: The correction client is only available to users who have been assigned the "Personal" role!



Monthly view

The required employee can be selected by typing the name in the Person field (Auto-Complete):

By entering the name, a list of employees with their first and last names is displayed, from which the required employee can be conveniently selected. As soon as the name entered is unique, its name including its group is automatically entered in the field (without any interaction with the mouse).

Alternatively, the desired employee can be selected by clicking on the 3 horizontal dots:

By clicking the blue arrow keys you can browse through the possible persons, years and months.

The current month is displayed in the **monthly view**. If you want to edit a certain day, you can do this either by clicking on the **edit** icon in the **action column** or by clicking on the **date** in the **date column** - but clicking on the date switches to the day view!

The following actions can be performed by clicking on the **edit symbol** in the relevant line:

Important: The **data of the previous month** can only be edited **until** the **15th of the current month**!

The following data can be edited:

- Enter or correct booked times
- Select the **absence reason** from the dropdown list:
 - (0) A = Present
 - (1) U = paid holiday
 - (4) KR = Sick with continued pay
 - (6) SE = Seminar
 - (7) ZA = time compensation
 - (8) DR = Business trip
 - (9) DG = off-site work
 - (11) AZ = physician
 - (14) AM = official channels
 - (20) TA = teleworking
- HT Set markers if it is only a half-day false reason
- Pa Pause deduction Authorization for pause deduction (automatic)
- **Ra** Frame Authorization Authorization for Booking Out of Frame



- 10 10h capping Activate daily 10h capping
- 50 50h capping Activate weekly 50h capping

After the data has been corrected / entered:

With **Save** (Floppy Disk Icon) the entries are accepted, with **Cancel** (Stopp Icon) the changes are discarded. Click on the **delete icon** (Stopp Icon) to delete an existing time entry. With a click on the **new symbol** (Sheet Paper Icon) another **entry** for the day can be added.

Daily view

Clicking on the date in the **date column** takes you to the **daily view**. Here you can also make changes to the day entries by clicking on the **edit symbol**, analogous to the month view. By clicking on the **delete symbol** an existing time entry is deleted, by clicking on the **new symbol** another **entry** for the day can be made.

The following permissions can be set in this view:



- **Pausenabzug / Pause reduction** If the check mark is set, no automatic pause is deducted from the employee on the day in question.
- Example: Employee works from 08:00 to 16:00 without booking a lunch break. If the check mark is NOT set for break deduction, 30 minutes of lunch break are automatically deducted (since his working time is more than 6 hours) and his balance is credited with 7 hours 30 minutes. If you tick the box, the 30 minutes are not deducted and 8 hours are added to the balance.
- **Rahmenberechtigung / Frame authorization** In addition to frame authorization, i.e. also work performed outside the defined frame time is included in the balance.
- Example: Frame time from 8 to 20 o'clock. Employees arrive at 07:30. If the check mark is not set, the 30 minutes before 8 a.m. do not count as working time (that is, not in the balance) if the check mark is set, however, the 30 minutes do count as working time (in the balance).
- **10h Kappung / 10h capping** Activate 10h capping for the day in question.
- Example: Employee A works from 8 to 19:30. A half hour lunch break is automatically deducted, i.e. the actual working time is 11 hours. If the 10h capping is activated, the considered day counts only with 10h in the balance everything which goes beyond it is capped.
- **50h Kappung / 50h capping** Activate 50h capping for the week in question.
- Example: the 50h capping behaves like the 10h capping only that for the evaluation not only a single day but the entire working week is used.

The following accounts can be corrected in this view:

- Resturlaub / Remaining vacation
- Example: Employee A should be entitled to 5 days more remaining leave from the day in question. By clicking on the Edit symbol, entering +5 and clicking on Save, the changes are accepted and apply from the key date in question (in this case from 01.10.2013).
- **GLZ-Saldo 1:1 / GLZ balance 1:1** this account is used to correct the normal working flextime balance.
- Example: Mr. Gschaftig has in the above example a balance of -41:42 hours. If we now want to reduce his balance to -20:00 hours, we would activate the account GLZ balance 1:1 by clicking on the Edit icon. Then enter +21:42 and click on the Save icon. This will correct the balance to 20:00 hours. The same procedure applies if we want to correct the balance downwards in this case simply use a (minus) before the number instead of the + (plus)!
- Überstunden (Üst xx%) / Overtime (Üst xx%) 25% and 65% Overtime
- Example: Mr. Rauhbein would like to be paid 10 of his 25% overtime. So you have to reduce the 25% overtime account by 10 hours: Edit / -10 / Save. The same principle applies to 65% overtime.

Important: The changed values for balance and remaining leave are valid as of the key date, that is, in the above example, a correction of the remaining leave or balance would have the key date 1 October 2013.



Change daytime programs

In addition to time entries and corrections, **day programs** can also be exchanged in the **daily view**. To do this, click on the edit icon next to the day program:



The available daily programs are different depending on the client. After selecting the desired day program, click on the **Save icon** to accept the new day program for the selected day. With a click on the **cancel symbol** the change is canceled, the original day program appears again.

Account corrections (absolute + relative)

As mentioned above, account corrections can also be made (in the day view).

Important: Account corrections can only be made in the **daily view**. They always apply as of the key date (the key date always corresponds to the day currently selected)!

The change can be both absolute (e.g: Input of 5 as remaining vacation - sets the remaining vacation to 5 days, no matter which value was posted to the account so far) as well as relative (e.g: Enter +10 as Remaining vacation - sets the remaining vacation to Remaining vacation old + 10 days = Remaining vacation new).

The account is changed to the value entered after entering a number and clicking the **Save** icon.

5.6.7.4 Absence Client

General

With the **Absence Client**, absences that extend over one or more days can be entered in a simple manner.

The desired employee can be selected by typing the name in the Person field (Auto-Complete):

By entering the name, a list of employees with their first and last names is displayed, from which the desired employee can be conveniently selected. As soon as the entered name is unique, its name is automatically entered in the field (without any interaction with the mouse).

Alternatively, the desired employee can be selected by clicking on the 3 horizontal dots:





5.9.1 Correction-Client

General

The **booking and absence time corrections** serve the recording of **time bookings or absence times in hours**, as well as the **correction** of already existing bookings.

The recording can be done in a **monthly** or **daily view**.

Important: The correction client is only available to users who have been assigned the "Personal" role!

Monthly view

The required employee can be selected by typing the name in the Person field (Auto-Complete):

By entering the name, a list of employees with their first and last names is displayed, from which the required employee can be conveniently selected. As soon as the name entered is unique, its name including its group is automatically entered in the field (without any interaction with the mouse).

Alternatively, the desired employee can be selected by clicking on the 3 horizontal dots:

By clicking the blue arrow keys you can browse through the possible persons, years and months.

The current month is displayed in the **monthly view**. If you want to edit a certain day, you can do this either by clicking on the **edit** icon in the **action column** or by clicking on the **date** in the **date column** - but clicking on the date switches to the day view!

The following actions can be performed by clicking on the **edit symbol** in the relevant line:



Important: The **data of the previous month** can only be edited **until** the **15th of the current month**!

- Select the **absence reason** from the dropdown list:
 - (0) A = Present

- Ra Frame Authorization Authorization for Booking Out of Frame
- 10 10h capping Activate daily 10h capping
- 50 50h capping Activate weekly 50h capping

After the data has been corrected / entered:

With **Save** (Floppy Disk Icon) the entries are accepted, with **Cancel** (Stopp Icon) the changes are discarded. Click on the **delete icon** (Stopp Icon) to delete an existing time entry. With a click on the **new symbol** (Sheet Paper Icon) another **entry** for the day can be added.

Daily view

Clicking on the date in the **date column** takes you to the **daily view**. Here you can also make changes to the day entries by clicking on the **edit** symbol ☑ , analogous to the month view. By clicking on the **delete** symbol ☑ an existing time entry is deleted, by clicking on the **new** symbol 〗 another entry for the day can be made.



All accounts with a 🊺

next to them can be edited. Both absolute and relative corrections can be made. More about this under the item **Account corrections (absolute + relative)**!

Authorizations for the selected day can also be assigned / withdrawn (set / remove the check mark for the corresponding authorization):

- **Pause reduction** If the check mark is set, no automatic pause is deducted from the employee on the day in question.
- Example: Employee works from 08:00 to 16:00 without booking a lunch break. If the check mark is NOT set for break deduction, 30 minutes of lunch break are automatically deducted (since his working time is more than 6 hours) and his balance is credited with 7 hours 30 minutes. If you tick the box, the 30 minutes are not deducted and 8 hours are added to the balance.
- **Frame authorization** In addition to frame authorization, i.e. also work performed outside the defined frame time is included in the balance.
- Example: Frame time from 8 to 20 o'clock. Employees arrive at 07:30. If the check mark is not set, the 30 minutes before 8 a.m. do not count as working time (that is, not in the balance) if the check mark is set, however, the 30 minutes do count as working time (in the balance).
- **10h capping** Activate 10h capping for the day in question.
- Example: Employee A works from 8 to 19:30. A half hour lunch break is automatically deducted, i.e. the actual working time is 11 hours. If the 10h capping is activated, the considered day counts only with 10h in the balance everything which goes beyond it is capped.
- **50h capping** Activate 50h capping for the week in question.
- Example: the 50h capping behaves like the 10h capping only that for the evaluation not only a single day but the entire working week is used.

The following accounts can be corrected in this view:

Remaining vacation

Example: Employee A should be entitled to 5 days more remaining vacation from the day in question. By clicking on the Edit symbol, entering +5 and clicking on Save, the changes are accepted and apply from the key date in question (in this case from 01.10.2013).

- **GLZ balance 1:1** this account is used to correct the flexitime balance (the balance is the sum of the accounts GLZ balance 1:1, 1:1.5, 1:7 and 1:2). *Example: Mr. Rauhbein has a balance of 0:00 hours in the above example. If we now want to increase his balance to 20:00 hours, we would activate the account GLZ balance 1:1 by clicking on the Edit icon. Then enter +20:00 and click on the Save icon. This will correct the balance to 20:00 hours. The same procedure applies if we want to correct the balance downwards in this case simply use a (minus) before the number instead of the + (plus)!*
- **GLZ balance 1:1.5** this account is used to correct the flexitime balance in case 50% overtime should not be paid out but should be booked to the balance (the balance is the sum of the GLZ balance accounts 1:1, 1:1.5, 1:7 and 1:2).



Example: Mr. Rauhbein would like to have 10 of his 50% overtime hours credited to his balance. You correct the accounts as follows: -10 for account Üst 50% pfl (edit and save) and +15 (10 times 1.5) on account GLZ balance 1:1.5 (edit and save).

- **GLZ balance 1:1.7** this account is used to correct the flexitime balance (the balance is the sum of the GLZ balance 1:1, 1:1.5, 1:7 and 1:2 accounts). *Example: Mr. Rauhbein would like to have 10 of his 70% overtime hours credited to his balance. You correct the accounts as follows: -10 for account Üst 70% pfl (edit and save) and +17 (10 times 1.7) on account GLZ balance 1:1.7 (edit and save).*
- **GLZ balance 1:2** this account is used to correct the flexitime balance (the balance is the sum of the GLZ balance 1:1, 1:1.5, 1:7 and 1:2 accounts). *Example: Mr. Rauhbein would like to have 10 of his 100% overtime hours credited to his balance. You correct the accounts as follows: -10 for account Üst 100% pfl (edit and save) and +20 (10 times 2) on account GLZ balance 1:2 (edit and save).*
- Overtime (Üst xx%) 25%, 50%, 65%, 70% and 100% overtime taxable (pfl) and tax-free (fr)

Example: Mr. Rauhbein would like to be paid 10 of his 25% overtime. So you have to reduce the 25% overtime account by 10 hours: Edit / -10 / Save. The same principle applies to 50, 65, 70 and 100% overtime. A reposting to the balance is of course also possible - see the 4 points above.

Important: The changed account values and authorizations are valid as of the key date, that is, in the above example, a correction of the remaining leave or balance would have the key date 12.08.2013.

Change daytime programs

In addition to time entries and corrections, **day programs** can also be exchanged in the **daily view**. To do this, click on the edit icon next to the day program:



The available daily programs are different depending on the client. After selecting the desired day program, click on the **Save icon** to accept the new day program for the selected day. With a click on the **cancel symbol** the change is canceled, the original day program appears again.

Account corrections (absolute + relative)

As mentioned above, account corrections can also be made (in the day view).
